Concerns with the handling and/or storage of soda ash and lime in Argentia was brought to the Town of Placentia's attention. Staff contacted provincial officials with the Department of Environment and with Occupational Health and Safety. Those two departments are dealing with the issue.

## **New Lighting Initiative**

It is the Town's understanding that in the new year, Newfoundland Power will be switching to LED lighting when replacing burned out street lights or installing new lights on poles.

## PUBLIC SAFETY COMMITTEE REPORT

(Councillor Noella Collins, Chair; Councillors Lorraine Collins-Power and Councillor Jane Hynes; Resource Person - CAO)

The Public Safety Committee Chair reported on matters discussed at the recent meeting.

Staff are assessing the costs to repair a malfunctioning radar sign in Dunville.

Business owners will be advised that where possible, delivery trucks are to use Veterans Way. The same correspondence will go to heavy equipment operators.

The animal holding pound needs repair to the exterior of the building.

Residents are to be reminded that boats are not to be stored on town owned property or the side of the provincial highway.

New signage is requested to identify school bus stops and warn of approaching crosswalks.

All taxi owners are reminded that permits expire at midnight on December 31.

A provincial grant has been received to offset 60% of the cost of four bunker suits for the fire department.

New signage is to be installed on the Veterans Way Boardwalk stating that only service dogs are permitted. The MEO will be asked to include monitoring of this site as part of his regular patrols.

## **CULTURE & TOURISM COMMITTEE REPORT**

(Councillor Jane Hynes, Chair; Councillor Noella Collins and Councillor Kay Smith; Resource Person - Manager of Tourism, Marketing and Communications)

Preliminary discussions have been held with the Atlantic Canada Opportunities Agency regarding funding for projects for the Arts Centre. The Committee will be discussing an application that will enhance the facilities existing set-up to accommodate more types of smaller scale gatherings. Council is appreciative of any support and will strive to not be competitive with local business.

A structural assessment of the convent has been done by an experienced stone mason. His report is anticipated within the next couple of weeks. Early assessment indicates that only the front facade of the building is actual stone from Ireland; the rest of the building is rubble. The Town needs to enter into discussion with the parish on ownership of the building and land. Serious deliberations will take place in the near future as to the disposition of this building.

The Placentia Farm and Market Association has held three farmers' markets to date which were quite successful. However, if the Town is to continue as a partner in this initiative, there must be municipal representation on the board and a presence at all meetings.

The Legendary Coast annual general meeting was recently held and Councillor Jane Hynes retains her position of regional director for the Cape Shore region. Valuable connections are made with other tourism personalities through organizations such as this. Councillor Hynes will present the Town of Placentia's issues as well as those of the region at this venue.

Hospitality NL has been invited to offer tourism best practices seminar(s) in Placentia for the benefit of local tourism workers.

The Town is very excited about the new wayfinding signage project for which funding was recently approved. Formal announcement will take place at the Arts Centre on Friday, November 16. Projects such as this benefit both domestic and industrial tourism.

Billets are being sought for the 2019 visit by an Irish delegation coming to Placentia from August 28 to September 1. Planning for this event will continue at the committee level.

Some work was accomplished at the Fort Louis Archaeology site in recent weeks. All committees of council will continue in their pursuit to ensure that this site is given due respect and kept up to standard.

The annual Light Up the Square event takes place on the 26th of November. In an effort to be environmental conscious, the committee has agreed to not give out glow sticks this year. Instead, candy canes will be distributed.

In addition to the events previously mentioned, the Mummers Parade is taking place on December 30th. The event will start with a free all ages workshop from 10:30 to 2:00 followed by the parade to the two seniors homes in Placentia.

#### RECREATION COMMITTEE REPORT

(Councillor Jamilee Fitzpatrick, Chair; Councillor Lorraine Collins-Power and Deputy Mayor Keith Pearson; Resource Person - Manager of Recreation and Community Programming

A brief synopsis of the Recreation Committee's activities includes the report that the dugouts in Dunville have been torched and are now complete.

The Recreation Advisory Committee (RAC) is up and running with 12 members at this time. A terms of reference is being drafted and all members agree that a unified application for funding that could be disbursed internally would serve the community better. A session on this topic is arranged for December 4.

The Trunk or Treat in the Town Square was a tremendous success. Congratulations went out to the residents, businesses and organizations who contributed to making this such a great event. Congratulations and thanks for the support.

#### COMMUNITY ENGAGEMENT AND COMMUNICATIONS

(Councillor Lorraine-Collins Power, Chair; Councillor Noella Collins and Councillor Jamilee Fitzpatrick; Resource Person - Manager of Tourism, Marketing and Communications)

The Chair briefly reported that the public consultation meeting took place on November 8th and that there was increased public input on-line. All suggestions and comments will be reviewed during the budget process.

This year, instead of focusing on anti-bullying, the Town of Placentia is seeking ways to promote the importance of respect and fairness in the workplace. Ideas how to best achieve this positive spin on this topic are sought from Council.

Correspondence for the month was circulated in advance and dealt with by the different committees of Council.

### **COUNCILLORS' CONCERNS/COMMENTS**

The maintenance work achieved by the partnership between the Public Works Department and the Department of Transportation and Works was well noted throughout the community. Council hopes to continue a similar partnership in the future. Mayor Power has written to thank the Minister and the Province.

Heavier than normal winds were experienced this past week, but the Town did not report any serious damage. Residents are reminded to secure smaller/loose property.

Residents are reminded that snow season is upon us and that it is not permitted to shovel snow into the streets for safety reasons.

With the early dark hours and the number of outside events coming up, all citizens are encouraged to exercise safety when driving and walking.

The Manager and Staff of the Public Works Department were acknowledged for their continued hard work and dedication to their jobs. They continue to work outside normal working hours as needed without hesitation and this is appreciated.

All committees have been individually working on budget preparations and Council will begin meeting as a whole on the budget next week.
