A discount of 10% is applicable to **Residential Property, Water & Sewer taxes, Only.** All taxes must be paid in full by April 2, 2024 to avail of the 10% discount on all current taxes.

The 2023 Municipal Taxes are due June 30, 2024. Simple Interest charges of 4.5% will be charged on all outstanding balances on June 30th and December 31st. Any collection fees incurred on individual accounts will be charged to taxpayers. If your account is paid in full by December 31, 2024 with 12 equal payments starting January 2024, Interest will be adjusted.
