The Town of Placentia signed a proclamation in support of Purple Day for Epilepsy. Purple Day is a global effort to promote Epilepsy Awareness in countries around the world. Epilepsy is a chronic neurological disorder, which affects each person differently, estimated to affect more than 10,000 people in Newfoundland and Labrador, over 300,000 people in Canada, and 50 million people worldwide. Purple Day will be celebrated on March 26th annually to increase understanding, reduce stigma, and improve the quality of life for people living with epilepsy throughout the country and globally.
